# IAC Program

Energy assessments are performed by a team consisting of a Syracuse University faculty member and upper level undergraduate and graduate engineering students. During a site visit, students take measurements to assess how the facility uses energy and resources. With the guidance of their professors, students then generate a confidential report identifying opportunities to save energy, reduce waste, and improve productivity. On average, implemented IAC assessment recommendations save a facility over \$70,000 annually.

## Assessment Process

### Pre-Assessment

Analysis of utility bills along with a pre-assessment survey detailing usage data provided by the company.

### Site Visit

IAC team conducts a one-day site visit to study the manufacturing process and to make energy, material waste and productivity-related measurements using diagnostic equipment.

### Report

Within 60 days of the assessment, the IAC team submits a confidential report to the company detailing the team's analysis and money-saving recommendations, along with estimates of related costs, performance, and payback periods.

### Follow-Up

Approximately six months after the assessment, the IAC team contacts the company to determine which recommended



## Eligibility

- Gross sales below \$100 million
- Annual utility bills more than \$100,000 and less than \$6 million
- No in-house professional staff to perform an assessment
- Be categorized in SIC 20-39 or NAICS 31-33
